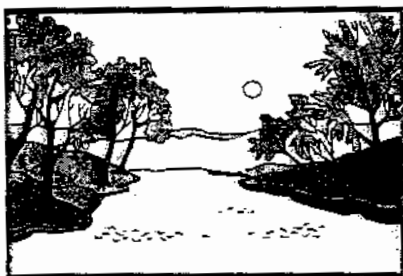

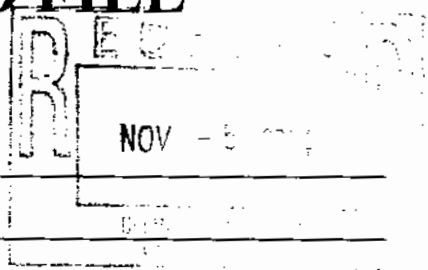


To: Three Rivers Levee Authority
