Re: Revised TRLIA 2nd 200-yr Goldfields Levee Project Quarterly Progress Report (QPR) dated July 24, 2018 for UFRR Funding Agreement # 4600012115

Attached for your review and approval is the Revised 2nd UFRR QPR for the time period of January to March 2018. The original 2<sup>nd</sup> UFRR QPR was submitted on March 29, 2018. A paper copy of the attached document has also been mailed to your office.

Based on the projected costs for Quarter 2 and Quarter 3, TRLIA previously requested an advance of \$533,825 covering 90% of the State's share for the next two-quarters less funding received from the advance received from the prior Quarter Report. The previous request did not account for an ENGEIO markup reduction from 20% to 5% and did not track retention being withheld and not paid on the True Up costs. As a result of these changes TRLIA requests an advance of \$489,202.

TRLIA is also requesting a True-Up of Local Credit for Costs incurred in the 1<sup>st</sup> Quarter of \$52,038.

The total request is \$541,240 (\$489,202 + \$52,038).

On February 14, 2018 DWR approved the initial credit request in the State's share of \$575,807.83. This initial credit request covered costs incurred through August 2017. On March 28, 2018 a supplemental credit request was prepared (submitted via separate letter) covering cost incurred after the initial credit request to October 3, 2017. The State's share of Total Expenses associated with the supplemental request was \$585,204.87. On June 20, 2018, a revised supplemental request was submitted addressing the previously noted adjustment on ENGEIO reimbursable expenses from 20% down to 5%. The creditable expenses for the project totaled \$661,085.49, with the State's share totaling \$561,922.67.

These changes impact the 3<sup>rd</sup> quarter report that was submitted June 20, 2018. An updated transmittal letter and report is in progress and will be submitted.
